The trouble with writing a Year's End wrap-up letter is that we never get it done before Christmas because well, the year hasn't ended yet. Nonetheless, here's hoping your 2004 was great and 2005 will be all the better. It's been an interesting year, to say the least. It sure has been trying politically, with the distressing national presidential election. But, we also had a fantastic win, locally. More about that later.

#### A tale of three booklets

This year we didn't write or publish any new books, as such, but we had a hand in three booklets. Last year Mikki worked with her mom, Bernice, to write up her life story, and this year we edited text, compiled photos and pulled it all together into *My Memoirs*, by Bernice Malin. Best of all, it was ready in time to be her 21st birthday gift (she's a leap year baby with 84 solar years) in a very limited edition for family members. Bernice was so happy to see it.

Mikki collaborated with Americans for Safe Access on a booklet telling the personal stories of *Patients in the Crossfire: Casualties in the War on Medical Marijuana.* Meanwhile, Chris put together a booklet on *Cannabis Yields and Dosage*(safeaccessnow.net) to show the science behind his court testimony and explain in general how marijuana is grown and used for medications. We are now getting copies into the hands of attorneys, policy makers and influential politicians to encourage them to establish reasonable guidelines to avoid arrests and protect access for qualified patients. This year both Santa Cruz and Humboldt counties adopted new ordinances similar to his proposal, so the work is showing its effect.

# Courting liberty and justice for all

Chris is still active as a cannabis expert in the courts. His testimony was given favorable mention by the state Court of Appeals when it upheld the defense in the Arbacauskasruling. The case benefits people in all criminal cases because prosecutors must now show new evidence to re-file charges once they are dismissed by a judge. This is the fourth Appeals Court case (plus one state Supreme Court case) where he is mentioned, but the first time the Court went into so much depth regarding his testimony. Unfortunately, he is still busy defending too many people facing prison. Enough already! Two federal cases to mention are the HIA victory over the DEA that protects hemp foods, and our friend Angel Raich took her medical marijuana case to the US Supremes.

# Measure Z wins election mandate

As an Oakland Civil Liberties Alliance board member, Mikki spent lots of time and energy working to get a city initiative on the ballot and pass it. Measure Z makes private, adult marijuana offenses (including sales) law enforcement's lowest priority and puts it on the record that city voters want to tax and regulate cannabis sales like alcohol as soon as possible under state law (see more at yesonz.org). Chris naturally got heavily involved. It was exciting to get great endorsements from elected officials and mainstream groups including State Sen, Don Perata, Rep. Barbara Lee, all the Democratic clubs, and many others. It was an intense campaign, but we had a great team and learned a lot. Oakland voters passed Z by over 65%.

Imagine our victory party – quite a bipolar experience, with our local win transposed against the bleak national outcome in which the Reds seized power, by hook or by crook.

# Keeping our show on the road

We didn't have an extended vacation this year, but we were lucky enough to get a few visitors, and to take a few days off here and there during work trips. In March we spent almost a week soaking in minerals at David Walley's Hot Springs, NV. We drove to nearby Reno for dinner, saw a great Riverdance show, Spirit of the Dance, and lost \$1.25 to the slots.

We were honored in April to receive the National Organization for the Reform of Marijuana Laws Outstanding Citizen Activism award at it's annual convention. That took us to Washington DC, where we met with Congressional staffers, and joined in the March for Women's Lives. While in the area, we visited Chris' mom in Maryland. She's still pretty snug in her little red house in the country and working at the school library. Then we drove to New York to speak at the Million Marijuana March there, and participated in an event at SUNY, New Paltz before coming home.


We spent a few days in Las Veşas for a Marijuana Policy Project workshop. For Mikki's birthday we
